RCE has met requirements set by SAC in both qualitative and quantitative aspects, specifically on public perception of the company's activities and the two-tier quantitative approach benchmarking on business activities and financial ratios.

The classification status takes effect from 26 November 2021. From the same review, there were 33 new additions and 25 deletions.
